## "Invitation to Submit Proposals for 20MW MEZ1 Power Supply"

#### 1. General Information:

In compliance with Philippine Economic Zone Authority (PEZA) Board Resolution No. 23-227, titled "PEZA Policy guidelines for the Competitive Selection Process (CSP) in the Procurement of Supply Requirement of Public Economic Zones" dated September 7, 2023 and Section 1.2.4 of the Lease Concession Agreement executed between MECO and PEZA.

Mactan Electric Company, Inc. (MECO) the Franchisee for the conveyance, construction and distribution of electric energy in the City of Lapu-lapu and the municipality of Cordova under Republic Act (RA) 10890 and a Certificate of Public Convenience and Necessity (CPCN), thru its MEZ1-CSP Bids and Awards Committee (MEZ1-CSP-BAC) is inviting qualified bidders to offer its proposal for a contract quantity of 20MW for the period December 26, 2024 to December 25, 2029 for the supply to Mactan Economic Zone 1 Locators.

The MEZ1 CSP process shall be govern by the PEZA board resolution no. 23-227 dated September 7, 2023 and guidelines establish in accordance to the resolution as included in the Bidding documents.

## 2. Pre-Qualification Requirements:

Interested Power Generation Companies to participate in this CSP are required to submit and comply with the "Pre-Qualification Requirements" as indicated below. In addition, it shall secure the bidding documents from Secretariate after compliance to (a) by showing the original official receipt of the payments.

a. Payment of non-refundable fee of Eight Hundred Thousand Pesos (Php 800,000.00) VAT excluded. Account Details shall be inquired from the MECO-CFO.

- b. Notarized Letter of Intent indicating the full name of the company, primary address, contact details (landline, mobile, email, etc.) signed by an authorized representative and shall subscribe to the bidding process.
- c. Oath of undertaking on non-legal action against MEZ1-CSP-BAC, MECO and PEZA, its representatives, officers & BOD, related to the CSP process and procedure/s format prescribed by the MEZ1-CSP-BAC.
- d. Original or Certified True Copies of all corporate/ legal documents (e.g. Board Resolution, Powers of Attorney) evidencing grant of authority invested in the individual submitting the Bid and making representation on behalf of the bidder.
- e. Duly notarized non-disclosure undertaking prescribed by the MEZ1-CSP-BAC.
- f. Scanned copy of the payment of the non-refundable fee.

Power Generation companies that complied with the above shall be allowed to participate in the CSP. The above requirement shall be submitted to the Secretariate on or before September 02, 2024, during office hours.

#### 4. Bidders Instruction:

Prospective Bidders shall obtain a copy of the Pre-Qualification Documents at MEZ1-CSP-BAC Secretariate at MECO Building, Sangi Road, Pajo, Lapu-lapu City on as prescribe below before 5:00pm in and shall submit the same as prescribed. Further the Prospective Bidders shall present proof of payment of the non-refundable fee before it can be given the documents.

Only prospective Bidders that have complied with Pre-Qualification documents and proof of payment of the non- refundable fee are the only party allowed to submit clarificatory question/s or participate in any of the Conference. Each Prospective Bidders will only have three (3) representatives allowed to join in the pre-bid conference.

Submissions of CSP documents shall be addressed to the MEZ1- CSP- BAC Chairman through the CSP Secretariat at MECO Building, Sangi Road, Pajo, Lapu-lapu City.

Bidders should adhere to all instruction specified in the Rules and Guideline for the Conduct of the 20 MW CSP on the Procurement of the Power Supply for Mactan Economic Zone 1 (MEZ1).
